## **Terms and Conditions**


- Facilities are limited to community or charitable functions and shall have approval by the city/town to be in public right of way.
- The care and maintenance of the facilities is the responsibility of the Applicant. OG&E will reserve the right to remove any facilities that become hazardous, damaged, in disrepair, abandoned or are installed improperly.
- Applicant shall reimburse OG&E for any damage to OG&E poles caused by the facilities or the installation and removal of the facilities.
- OG&E shall designate poles for attachment.
- Banner/sign size must be approved by OG&E based on the size and type of pole.
- Attachment of facilities to OG&E poles shall be done without drilling. Non-corrosive ties or bands approved for use by OG&E can be used. Do not use bolts or lag screws unless specifically approved by OG&E.
- Applicant 's facilities shall be used and attachment thereof to OG&E's poles shall be made, maintained and operated at Applicant's sole risk and expense and in accordance with the requirements and specifications of the National Electric Safety Code, the National Electric Code, the laws of the State of Oklahoma, Municipal Ordinances and Regulations, the Occupational Safety and Health Act, and OG&E's Standards for Attachments now in effect or which may be hereinafter made effective, including but not limited to the specifications contained on Exhibit "A" which is attached hereto and made a part hereof.
- Applicant shall at any time, at its own risk and expense, upon written notice from OG&E, change, alter, improve, remove, or renew its property hereby covered in such manner as OG&E may direct. Should it become necessary at any time to change the location of any of Applicant's facilities from one position to another on OG&E's poles, such work shall be done by Applicant at its sole risk and expense.
- Applicant shall indemnify and hold harmless OG&E and its representatives, agents, officers and employees from and against any and all loss, damage, or liability resulting from demands, claims, suits, or actions of any character presented or brought for any injuries (including death) to persons and for damages to property caused by or arising out of any negligent (including strict liability), wanton or intentional act or omission of Applicant, anyone directly or indirectly employed by it, or anyone for whose acts it may be liable, in any way associated or connected with the performance of the obligations herein, in whatever manner the same may be caused. It is the expressed intent of the parties that OG&E shall be liable only for those damages attributable to its own negligence and shall not be liable for any damages (either economic or non-economic) attributable to the acts of any other person or entity. The foregoing indemnity shall include, but not be limited to, court costs, attorney's fees, costs of investigation, costs of defense, settlements and judgments associated with such demands, claims, suits or actions. Applicant shall give an immediate notice to OG&E of the occurrence of any personal injury or property damage, occurring at OG&E's poles.


