INSTRUCTIONS FOR OKC-SWQ FORM CC - 1 PERMIT APPLICATION FOR COSMETIC CLEANING OPERATIONS

Who Must File A Permit Application for Industries Associated With Cosmetic Cleaning Operations

Any person who engages in commercial cosmetic cleaning is required to apply for a permit. Cosmetic cleaning is defined as any system, machine, or substance used to remove undesirable substances from any surface or façade creating free foreign matter.

Oklahoma City Municipal Code Chapter 57-190 adopts by reference Federal law at 40 CFR part 122 and also by reference in Oklahoma Administrative Code 252:606-5-5 prohibiting point source discharges of storm water associated with industrial activity to a water body(ies) of the US without a Municipal Storm Water Discharge Permit. Completing The Form

You must type or print, using upper-case letters, in the appropriate areas only. If you have any questions on this form, call The City of Oklahoma City at (405) 297-1774.

Section I. Business Information

Enter the Business's name and complete street address, including city, state, and ZIP code, for which you are making this application.

Section II. Owner/Operator Information

Enter legal name and telephone number of the owner/operator of the business for which you are applying for a permit. Do not use a colloquial name.

Section III. Vehicle Information

Enter the description and vehicle license registration number of each vehicle to be registered under the license.

Enter the license number of the trailer, if one will be used.

Section IV. Disposal Method

Check the appropriate box for the filtration and containment process that will be used.

Any applicant who utilizes wash water recycling units must list all sanitary sewer discharge locations the applicant intends to use. List the Industrial Pretreatment disposal location and Permit #, if applicable.

Section V. Certification

Please print and sign your name showing that you have read the Certification Statement and understand that Federal Statutes provide for severe penalties for submitting false information on this application form.

General Information

A person commits an offense if the person operates or causes to be operated a mobile commercial cosmetic cleaning vehicle which does not display the registration number assigned to the vehicle. The Cosmetic Cleaning Permit Number must be displayed in a visible location on the vehicle or trailer registered under this permit in numerals of a minimum height of three inches.

A permit holder shall ensure that all of its employees engaged in mobile commercial cosmetic cleaning are knowledgeable of the discharge prohibitions to the Municipal Separate Storm Sewer System (MS4), and shall require all its employees to use best management practices when engaging in mobile commercial cosmetic cleaning.

A permit shall be valid for one year from the date of its issuance, unless suspended or revoked.

PLEASE MAKE SURE YOU ACQUIRE A COPY OF THIS PERMIT AND CAREFULLY READ ALL THE TERMS AND CONDITIONS.
